- 2 An enforcement case is concluded when one of the of the following occurs: a notice is issued; legal proceedings commence; a planning application is received; or the case is closed. Please note that the number of cases closed is not a sub-set of the number of cases concluded in that period - cases that are concluded in any given period may not be closed until subsequent periods, and cases that are closed in any given period may have been concluded in previous period.
- 3 The time taken to conclude an enforcement case is calculated from the date on which the complaint is received to the earliest date of the following: a notice is issued; legal proceedings commence; a planning application is received; or the case is closed.
- 4 The target conclusion time excludes departmental enforcement cases as these are not subject to the new statutory target.
