Dog licences

Change of address: please inform us of any permanent change of address and we will update our records.

Transferring a dog licence: if your dog dies you can apply for a certificate to transfer that licence to your new dog.

Refunding the licence fee: you can get a refund within 30 days from date of issue if; you do not get a dog, you have disposed of the dog or your dog dies.

Microchipping: your dog must be microchipped to be licensed. It is your responsibility to make sure that the contact details held on the appropriate database are accurate. If they are inaccurate, the dog is not considered microchipped and the licence is void.

Who can apply for a dog licence? It is an offence to apply for, or obtain a licence if you are under 16 or if you are disqualified from keeping a dog under; Article 33A of the Dogs (NI) Order 1983 as amended or Section 27 of the Welfare of Animals Act (NI) 1972.

Control Order: it is an offence to contravene any control condition attached to a dog licence. It is also an offence to give away or sell a dog which is subject to a control condition without informing the council in writing to the address overleaf.

Public scrutiny: any information you provide in this application is open to public scrutiny.

Dog licences

Dog Licence and identification tag: all dogs must have a valid licence and wear identification with the name and address of their keeper, either on a tag or engraved on a collar plate.

Dog Fouling: if you do not pick up after your dog immediately, you may receive a £80 fixed penalty notice.

Straying: you must always be in control of your dog and do not let it stray. If your dog is allowed to stray you may receive a £80 fixed penalty notice.

The Dogs (Specified Maximum) (Belfast) Order 2012: you can have only 4 dogs under your control, at any one time, while out in public. This order covers the entire Belfast City Council area, including all parks and open spaces.

Specific requirements for greyhounds, whippet and lurcher type dogs: greyhounds when exercised or led in a street or other public place must be kept under control and muzzled. No more than two greyhounds should be exercised or led by any one person in any street, road, highway or other public place.

Animal welfare

We enforce the powers in the Welfare of Animals (NI) Act 2011 in respect of domestic pets, horses and donkeys. People responsible for animals must take positive steps to ensure they care for their animals properly.
