## Main purpose of job

Belfast's Digital Innovation ambition is to support communities, companies, universities and other partner organisations to find and drive the science, technology, business models, processes and commercial innovations that will grow our economy and deliver on social, economic and environmental goals for the city.

As part of this ambition, Belfast Region City Deal partners have agreed to create a new £20m Fund aimed at stimulating collaborative innovation between industry, academia and the public sector in order to address key societal challenges. The fund will be designed to complement other investments and programmes planned by the city and its partners within the new Belfast Smart District area.

Reporting to Belfast City Council's City Innovation Manager the postholder will:

- be responsible for developing the project business case in order to draw down funding from the Belfast Region City Deal (BRCD) for the creation of the new innovation for societal impact fund.
- design and implement mechanisms for the fund's delivery, metrics for measuring its impact, and the monitoring and reporting processes to support Council and BRCD governance.
- work with them to engage with leaders and key influencers at the district, city, regional and national level in order to ensure the fund design complements and enhances local and regional objectives.
- work with the City Innovation team to develop an engagement, marketing and promotions strategy for the fund.
- support the commissioning and management of consultancy services to assist with the above.

## Summary of responsibilities and duties

1. Develop a mission-orientated challenge fund for the Belfast Smart District, aimed primarily at addressing societal challenges by stimulating collaborative innovation between public sector bodies, academia and industry.
2. Support the commissioning and management of relevant consultancy services to develop Northern Ireland Green Book Project Business Cases to draw down Belfast Region City Deal funding for the fund.
3. Create robust, transparent and open mechanisms to measure impact, contribute to learning and facilitate monitoring, audit, public and governance requirements.
4. Ensure regional and national alignment and the incorporation of best practice in relations and to engage with stakeholders on the ambition and purpose of the funds.
5. Manage the competitive process for the fund including establishment of stakeholder groups, industry experts and judges, proposal screening, selection of grantees, issuing of funding.
6. Work across with funding partners, industry groups and academia to ensure alignment of activities to maximise impact on challenges and sectors.
7. Lead the promotion of the fund among potential grant applicants through a range of bodies and organisations.
8. Provide regular reporting and assurance to the BRCD programme office on the development of the programmes and the management of the process.
9. Ensure all due diligence, approvals and governance processes are complied with.
10. Make recommendations and submit regular reporting as required within Belfast City Council approvals and financial controls process as well as the BRCD governance process.
11. Work with stakeholders from across government to identify and recommend processes and mechanisms for the promotion and operational management of the challenges. (for example, Innovate UK, Digital Catapult, or other).
12. Establish and manage the delivery contract of any third party (for example, Innovate UK or other) and ensure adequate representation involved in the assessment and oversight of the process, with a strong emphasis on due diligence, Value for Money and cost-effectiveness.
13. Motivate and manage any staff that may be assigned, to the post holder to ensure effective service delivery and to be responsible for reviewing and implementing a proper staff training and development programme.
14. Participate in all induction and in-service training provided by Belfast City Council and in the induction and support of all newly appointed staff and other human resource management policies and procedures, as appropriate, including, absence management, disciplinary and grievance procedure.
15. Participate as directed in the Council's recruitment and selection procedures.

  17. Undertake the duties in such a way as to enhance and protect the reputation and public profile of the council.

#### **Job applicant privacy notice**

Belfast City Council is the Data Controller under the General Data Protection Regulations (GDPR) for the personal data it processes relating to job applicants. Processing data from job applicants allows the council to manage the recruitment process, assess and confirm an applicant's suitability for employment and decide to whom to offer a job. ### **Appointment**

The appointment will be made by the selection panel, but will be subject to ratification by the director of the relevant department.

There may be a reserve list of applicants drawn up for this post which would last for a maximum of 12 months. Should a similar post become vacant within this time, it may be offered to those on the reserve list, in order of merit, without further interview. For generic-type posts, this may include posts in another department.

If a similar post does become vacant within this time, it will be offered to candidates on the reserve list in the following way:

1. Candidates will be initially contacted by telephone and **must** respond within three working days to accept or decline the post.
2. Candidates who cannot be contacted by telephone will be contacted by letter and **must** respond by telephone or by return of acceptance form within five working days of the date of the letter.

If candidates do not respond within the above time frames, the post will be offered, in order of merit, to the next person on the reserve list. The names of those candidates who have not responded within the above timeframes will be retained on the reserve list, in order of merit, to be considered for future vacant posts.

An existing temporary or fixed term contract employee will, if successful, be appointed on the basis of a further temporary or fixed term contract into a 'temporary project' post but with no automatic right to revert back to their original temporary or fixed term contract post. Similarly, an existing agency assignee will, if successful, be appointed on the basis of a 'temporary project' post but with no automatic right to revert back to their original agency assignment. ### **Remuneration**

The salary will be determined by the council in line with that determined by the National Joint Council for Local Government Services, currently Salary Scale PO8, SCP 46 to 48, £49,864 - £51,958 per annum (in normal circumstances, the starting salary is the minimum point), paid monthly by direct payment by the Bankers Automated Clearing System (BACS) to a bank or building society account of your choice.

### **Location**

The person appointed will be based initially in City Hall, Belfast but will be required to work in and/or visit other locations.

### **Pre-employment checks**

- (i) Complete a disclosure of criminal convictions form, under the Rehabilitation of Offenders (NI) Order 1978. ## **Council policies**

The person appointed will be required to comply with all current and future council policies, procedures, guidelines, agreed working practices and any relevant collective agreements incorporated into the contract of employment.

## **Conditions**

The general conditions of service as prescribed from time to time by the National Joint Council for Local Government Services and by the council for its officers shall apply to the appointment and the Single Status Implementation Agreement dated 2007 as renegotiated from time to time is hereby incorporated into the contract of employment.

## **Service and hours of duty**

The hours of duty are 37 per week, working five days per week, Monday to Friday. Flexible working hours are in operation between 7.30am and 6.30pm, with set core times that the person appointed must be in work. However, the person appointed will be required to start and finish work at specific times that suit the operational needs of the service and will, when advised, be required to work outside of these hours for operational reasons including on extra statutory, bank and/or public holidays.

In accordance with the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service variations to the established working week or patterns of work will be reasonable and subject to adequate notice.

## **Annual leave**

Annual leave and extra statutory, bank or public holiday entitlement is calculated in hours/minutes.

A person appointed on the standard full time hours of 37 per week will be entitled to 170.2 hours (23 days) annual leave, plus 88.8 hours (12 days) bank or other holidays.

Annual leave entitlement will be increased by 37 hours (5 days) in the case of officers who have not less than 5 years' continuous service and by a further 22.2 hours (3 days) in the case of officers who have not less than 10 years' continuous service.

Figures in brackets represent the number of days based upon a standard day of 7.4 hrs.

For individuals who do not work the standard full-time hours, annual leave and extra statutory, bank or public holiday entitlement will be calculated on pro-rata basis to their contracted hours, based on the standard full time hours of 37 per week and a standard day of 7.4 hours (i.e. 7 hrs 24 minutes).

Employees are entitled to a holiday with a normal day's pay for each of the statutory, general and public holidays as they occur. Where the balance of the employee's public / bank and statutory holiday entitlement has been exhausted, additional leave taken for public / bank and statutory holidays will be deducted from the employee's annual leave entitlement.

All employees required to work on extra statutory, bank or public holidays will be remunerated in accordance with Part 3, paragraph 2 of the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service.

The leave year commences on 1 April. If an employee starts part way through the annual leave year, the employee will receive annual leave entitlement on a pro rata basis, calculated on the number of days remaining in the current leave year from the first day of employment.

### **Sick leave**

This scheme is intended to supplement Statutory Sick Pay and Incapacity Benefit so as to maintain normal pay during defined periods of absence on account of sickness, disease, accident or assault. Absence in respect of normal sickness is entirely separate from absence through industrial disease, accident or assault arising out of or in the course of employment with a local authority. Periods of absence in respect of one shall not be set off against the other for the purpose of calculating entitlements under the scheme. Employees are entitled to receive sick pay for the following periods:

During first year of service	one month's full pay and (after completing four months service) two months half pay
During second year of service	two months' full pay, and two months' half pay
During third year of service	four months' full pay, and four months' half pay
During fourth and fifth years of service	five months' full pay, and five months' half pay
After five years' service	six months' full pay, and six months' half pay

### **Superannuation**

The person appointed will automatically become a member of the Local Government Pension Scheme (Northern Ireland) LGPS (NI) in line with scheme regulations. They may opt out of the scheme. However, the council is required to comply with automatic enrolment provisions and will automatically enrol the person appointed at certain times. The LGPS (NI) is administered by Northern Ireland Local Government Officers' Superannuation Committee (NILGOSC) ([www.nilgosc.org.uk](http://www.nilgosc.org.uk)).

### **Canvassing**

Canvassing in any form, oral or written, direct or indirect, will disqualify an applicant for appointment. Candidates can, however, contact the relevant department for further information about the post. The person from the relevant department who provides further information should not be a member of the selection panel.

### **Notice**

The minimum period of notice to be given by an employee shall normally be the ordinary period from one payment of salary or wages to the next.
