# Main purpose of job

Be responsible to the Business Coordinator for the day-to-day operational management of the business support function and for ensuring the duties of business support are undertaken in an economic, effective and customer focused manner, implementing a sound performance management approach within the business support section.

Be responsible to the Business Coordinator for the provision and supervision of an efficient and effective front line customer service to the public.

Be responsible for the supervision and maintenance of comprehensive service records in accordance with council procedures.

# Summary of responsibilities and personal duties

- 1. Assist the Business Coordinator with the production of the section's business plan, including the production and collation of service and performance data and statistics for committee reports, and publications in accordance with council policies, procedures and timetables.
- 2. Be responsible for programming the workload and priorities of assigned staff ensuring the smooth operation of a customer focused business support service on a daily basis to agreed time and quality targets.
- 3. In conjunction with the Business Coordinator identify the business support needs of the service and assist in developing and implementing systems and staffing arrangements to meet these needs.
- 4. Assist the Business Coordinator in the monitoring and management of the finances of the service in accordance with the councils' policies, financial regulations and standing orders so as to ensure that service objectives are met.
- 5. Assist the Business Coordinator in the management of all human resource functions within the service including sickness absence, recruitment and selection and employee relations matters.
- 6. Assist in the preparation of the service's revenue and capital programme estimates in liaison with the Business Coordinator.
- 7. Supervise the proper and efficient purchasing of goods and services and the maintenance of equipment in accordance with council policy.
- 8. Supervise the front-line customer support service and deal with public enquiries, assist with the administration of FOI requests and complaints in accordance with service and corporate procedures.
- 9. Assist and liaise with the council's Internal Auditor and Local Government Auditor as required.
- 10. Assist the Business Coordinator with the review of all financial and IT systems and procedures within Business Support and to make appropriate recommendations to ensure business needs are met.
- 11. Assist the Business Coordinator in providing advice and guidance to the Senior Management Team on the implementation and interpretation of human resources, financial and, general administrative matters.
- 12. Assist as directed in the implementation of any departmental change management activities.
- 13. Represent the service on corporate working groups and project teams as and when required.

- 14. Undertake service specific projects including research as required.
- 15. Represent within the post holder's area of responsibility, the Business Coordinator as and when required.
- 16. Assist as necessary in any of the Business Support duties of the service.
- 17. Participate as directed in the council's recruitment and selection procedures.
- 18. Act in accordance with the council and departmental policies and procedures including customer care; equal opportunities; health and safety; safeguarding and any pertinent legislation.
- 19. Participate in all induction and in-service training provided by Belfast City Council and in the induction and support of all newly appointed staff and other human resource management procedures as appropriate.
- 20. Undertake the duties in such a way as to enhance and protect the reputation and public profile of the council.
- 21. Undertake such other relevant duties as may, from time to time, be required.

This job description has been written at a time of significant organisational change and it will be subject to review and amendment as the demands of the role and the organisation evolve. Therefore, the post-holder will be required to be flexible, adaptable and aware that they may be asked to perform tasks, duties and responsibilities which are not specifically detailed in the job description but which are commensurate with the role.

#### Job applicant privacy notice

Belfast City Council is the Data Controller under the UK General Data Protection Regulation (UK GDPR) for the personal data it processes relating to job applicants. #### Appointment

The appointment will be made by the selection panel, but will be subject to ratification by the director of the relevant department.

#### There is currently one permanent, full time post.

There may be a reserve list of applicants drawn up for this post which would last for a maximum of 12 months. Should a similar post become vacant within this time, it may be offered to those on the reserve list, in order of merit, without further interview. For generic-type posts, this may include posts in another department. These posts may be either full-time, part-time or job share on a permanent, temporary or fixed-term basis.

If you are offered and you accept a temporary position e.g. a temporary part-time position for 3 months, and another temporary part-time position arises from the same recruitment campaign e.g. for 1 year, regardless of whether or not you are still working in your temporary part-time position, you will not be offered any further temporary part-time position. #### Remuneration

The salary will be determined by the council in line with that determined by the National Joint Council for Local Government Services, currently Salary Scale SO2, SCP 26 to 28, £32,909 - £34,723 per annum (in normal circumstances, the starting salary is the minimum point), paid monthly by direct payment by the Bankers Automated Clearing System (BACS) to a bank or building society account of your choice.

## Location

The person appointed will be based initially in 9 Adelaide, 9 - 21 Adelaide Street, Belfast but will be required to work in and/or visit other locations.

### **Pre-employment checks**

Prior to taking up duty the person recommended for appointment must:

- (a) Enter into an agreement which sets out the main terms and conditions of employment.

- (i) Complete a disclosure of criminal convictions form, under the Rehabilitation of Offenders (NI) Order 1978. ## **Council policies**

The person appointed will be required to comply with all current and future council policies, procedures, guidelines, agreed working practices and any relevant collective agreements incorporated into the contract of employment.

#### Conditions

The general conditions of service as prescribed from time to time by the National Joint Council for Local Government Services and by the council for its officers shall apply to the appointment and the Single Status Implementation Agreement dated 2007 as renegotiated from time to time is hereby incorporated into the contract of employment.

A copy of the council's Disciplinary Procedure and Grievance Procedure will be issued to all new employees at the council's Induction Course.

Please note if you are an applicant with previous local authority service in England, Scotland, Wales etc., you are advised to clarify your particular situation with regard to the continuity of this service, prior to accepting an offer of appointment from Belfast City Council.

#### Service and hours of duty

The hours of duty are 37 per week, working five days per week, Monday to Friday. Flexible working hours are in operation between 7.30am and 6.30pm, with set core times that the person appointed must be in work. However, the person appointed will be required to start and finish work at specific times that suit the operational needs of the service and they will, when advised, be required to work outside of these hours for operational reasons including on extra statutory, bank and/or public holidays.

In accordance with the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service variations to the established working week or patterns of work will be reasonable and subject to adequate notice.

#### **Annual leave**

Annual leave and extra statutory, bank or public holiday entitlement is calculated in hours/minutes.

A person appointed on the standard full time hours of 37 per week will be entitled to 170.2 hours (23 days) annual leave, plus 88.8 hours (12 days) bank or other holidays.

Annual leave entitlement will be increased by 37 hours (5 days) in the case of officers who have not less than 5 years' continuous service and by a further 22.2 hours (3 days) in the case of officers who have not less than 10 years' continuous service.

Figures in brackets represent the number of days based upon a standard day of 7.4 hrs.

For individuals who do not work the standard full-time hours, annual leave and extra statutory, bank or public holiday entitlement will be calculated on pro-rata basis to their contracted hours, based on the standard full time hours of 37 per week and a standard day of 7.4 hours (i.e. 7 hrs 24 minutes).

Employees are entitled to a holiday with a normal day's pay for each of the statutory, general and public holidays as they occur. Where the balance of the employee's public / bank and statutory holiday entitlement has been exhausted, additional leave taken for public / bank and statutory holidays will be deducted from the employee's annual leave entitlement.

All employees required to work on extra statutory, bank or public holidays will be remunerated in accordance with Part 3, paragraph 2 of the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service.

The leave year commences on 1 April. If an employee starts part way through the annual leave year, the employee will receive annual leave entitlement on a pro rata basis, calculated on the number of days remaining in the current leave year from the first day of employment.

#### Sick leave

This scheme is intended to supplement Statutory Sick Pay and Incapacity Benefit so as to maintain normal pay during defined periods of absence on account of sickness, disease, accident or assault. Absence in respect of normal sickness is entirely separate from absence through industrial disease,

accident or assault arising out of or in the course of employment with a local authority. Periods of absence in respect of one shall not be set off against the other for the purpose of calculating entitlements under the scheme. Employees are entitled to receive sick pay for the following periods:

During first year of service	one month's full pay and (after completing four months service) two months half pay
During second year of service	two months' full pay, and two months' half pay
During third year of service	four months' full pay, and four months' half pay
During fourth and fifth years of service	five months' full pay, and five months' half pay
After five years' service	six months' full pay, and six months' half pay

#### Superannuation

The person appointed will automatically become a member of the Local Government Pension Scheme (Northern Ireland) LGPS (NI) in line with scheme regulations. They may opt out of the scheme. However, the council is required to comply with automatic enrolment provisions and will automatically enrol the person appointed at certain times. The LGPS (NI) is administered by Northern Ireland Local Government Officers' Superannuation Committee (NILGOSC) (www.nilgosc.org.uk).

#### Canvassing

Canvassing in any form, oral or written, direct or indirect, will disqualify an applicant for appointment. Candidates can, however, contact the relevant department for further information about the post. #### Notice
