Main purpose of job

To be responsible through a Senior Environmental Health Officer (EHO) to a Principal Environmental Health Officer (EHO) for the improvement of the health and quality of life of people in Belfast through the efficient and effective delivery of specific work activities allocated to the post-holder.

To make an effective contribution to the development and achievement of the Environmental Health Service objectives and unit business plans.

To ensure that all duties and tasks assigned to the post-holder are performed in accordance with specified time and quality targets.

Post-holders may be required to handle and be exposed to food product allergens, for example, fish, peanuts, tree nuts, etc.

Summary of responsibilities and personal duties

- 1. Carry out specified enforcement, investigative, educational and advisory duties associated with the responsibilities of any area of work to which the postholder is assigned.
- 2. Actively participate in and progress through a structured development programme to build professional experience and competence.
- 3. Proactively liaise with other organisations (public, private, voluntary and community) to enhance the achievement of service and unit objectives.
- 4. Carry out project work as directed by the Principal EHO or Senior EHO.
- 5. Be responsible for organising personal daily work demands to ensure that all relevant agreed targets are achieved to ensure that a quality, customer focused environmental health service is delivered.
- 6. Provide such reports, records and statistical information as required.
- 7. Keep informed of all new developments within the area of work to which the postholder is currently assigned through a process of continuing professional development.
- 8. Proactively make suggestions for the improvement of work practices and services provided.
- 9. Occasionally work outside normal office hours and to provide occasional cover for out of hours services such as the night-time noise service as directed by the unit manager.
- 10. Participate as required in the training of students and other persons assigned to the unit for training purposes or work experience.
- 11. Motivate and manage any staff, that may be assigned, to the post-holder to ensure effective service delivery and to be responsible for reviewing and implementing a proper staff training and development programme.
- 12. Participate in all induction and in-service training provided by Belfast City Council and in the induction and support of all newly appointed staff and other human resource management policies and procedures, as appropriate, including, absence management, disciplinary and grievance procedure.
- 13. Participate as directed in the council's recruitment and selection procedures.
- 14. Act in accordance with the council and departmental policies and procedures including customer care, equal opportunities, health and safety, safeguarding and any pertinent legislation.
- 15. Undertake the duties in such a way as to enhance and protect the reputation and public profile of the council.
- 16. Undertake such other relevant duties as may from time to time be required.

This job description has been written at a time of significant organisational change and it will be subject to review and amendment as the demands of the role and the organisation evolve. Therefore, the post-holder will be required to be flexible, adaptable and aware that they may be asked to perform tasks, duties and responsibilities which are not specifically detailed in the job description but which are commensurate with the role. The post-holder should also be aware the location of this post in the organisational structure could be subject to change in the future.

Work planning skills: the ability to manage and prioritise a workload, to undertake required tasks independently and work to the specific technical criteria and targets.

Customer care skills: an understanding of customer relations issues and customer care procedures.

Belfast City Council is the Data Controller under the UK General Data Protection Regulation (UK GDPR) for the personal data it processes relating to job applicants. Appointment

The appointment will be made by the selection panel, but will be subject to ratification by the director of the relevant department.

There is currently one fixed term contract, full-time post until 31 March 2025 subject to review, which may be extended subject to funding arrangements; and one temporary, full-time post until 31 October 2024, subject to review.

There may be a reserve list of applicants drawn up for this post which would last for a maximum of 12 months. Should a similar post become vacant within this time, it may be offered to those on the reserve list, in order of merit, without further interview. **These posts may be either full-time, part-time or job share on a fixed term or temporary basis.**

If you are offered and you accept a temporary position e.g. a temporary part-time position for 3 months, and another temporary part-time position arises from the same recruitment campaign e.g. for 1 year, regardless of whether or not you are still working in your temporary part-time position, you will not be offered any further temporary part-time position.

However, in certain circumstances, when all relevant applicants on the reserve list for temporary vacancies, full-time or part-time, have been offered opportunities for which they expressed a preference on their application form, and if the timing of the reserve list is still valid and there are still temporary vacancies to fill before the reserve list expires, the council reserves the right to 'revisit' the reserve list in strict order of merit. Remuneration

The salary will be determined by the council in line with that determined by the National Joint Council for Local Government Services, currently Salary scale PO1, SCP 28 to 31, £34,723 - £37,261 per annum with additional allowances, where appropriate [please see below] (in normal circumstances, the starting salary is the minimum point), paid monthly by direct payment by the Bankers Automated Clearing System (BACS) to a bank or building society account of your choice.

For flexible working hour posts, the person appointed may be required to undertake work outside the normal office hours (as detailed under Service and hours of duty) and to provide occasional cover for out of hours services such as the night-time noise service. Any such work will be on an occasional basis and will attract additional payments.

For Port Health posts (for which a shift rota operates [as detailed under Service and hours of duty]), 20% shift allowance and weekend enhancement (currently under review), where appropriate, will be paid.

Location

The fixed term contract, full-time vacancy is based at Port Health, Corry Place, Belfast but the persons appointed will be required to work at the Border Inspection Post located within Belfast Port and will also be required to work in and, or visit other locations.

The temporary, full-time vacancy is based initially in the Cecil Ward Building, 4 – 10 Linenhall Street, Belfast and will also be required to work in and, or visit other locations.

A reserve list of successful candidates may be drawn up to last for a maximum of twelve months during which time similar posts may become available for other posts based at Port Health and **for**

flexible working hours posts, were the person appointed will be based initially in the Cecil Ward Building, 4 – 10 Linenhall Street, Belfast but will be required to work in and, or visit other locations.

Pre-employment checks

Prior to taking up duty the person recommended for appointment must:

- (a) Enter into an agreement which sets out the main terms and conditions of employment.

The general conditions of service as prescribed from time to time by the National Joint Council for Local Government Services and by the council for its officers shall apply to the appointment and the Single Status Implementation Agreement dated 2007 as renegotiated from time to time is hereby incorporated into the contract of employment.

A copy of the council's Disciplinary Procedure and Grievance Procedure will be issued to all new employees at the council's Induction Course.

Service and hours of duty

The hours of duty for full-time posts are an average of 37 per week and can be either on a flexible working or on a shift rota basis.

For the immediate vacancy in Port Health, the successful candidate will carry out shift work in various teams (as detailed below under Shift rota).

For the immediate vacancy based in the Cecil Ward Building, the successful candidate will carry out their duties on a flexible working basis (as detailed below under Flexible working hours).

Other posts may be filled from the reserve list on a flexible working or shift rota basis.

Flexible working hours

The hours of duty are 37 per week, working five days per week, Monday to Friday. Flexible working hours are in operation between 7.30am and 6.30pm, with set core times that the person appointed must be in work. However, the person appointed will be required to start and finish work at specific times that suit the operational needs of the service and she/he will, when advised, be required to work outside of these hours for operational reasons including on extra statutory, bank and/or public holidays.

In accordance with the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service variations to the established working week or patterns of work will be reasonable and subject to adequate notice.

The person appointed may be required to undertake work outside the normal office hours above and to provide occasional cover for out of hours services such as the night-time noise service. Any such work will be on an occasional basis and will attract additional payments.

Shift rota

The hours of duty are an average of 37 per week, working two weeks on day shift (am to pm) and two weeks on night shift (pm to am) (not necessarily consecutively) in various Teams per the example shift rotas below. The person appointed will be informed as to which team they have been assigned to. However, when advised, the person appointed will be required, for operational reasons, to work outside of these hours including on extra statutory, bank and/or public holidays.

Please note, shift rotas are subject to change and the successful applicants will be expected to work any new shift rota adopted by the council. Changes to the shift rota may include a variation to the start and finish times to ensure alignment with DAERA's (Department of Agriculture, Environment and Rural Affairs) shift patterns when they are agreed. These changes, if they occur, may have the potential to alter the 20% shift allowance and weekend enhancement payments as stated above under Remuneration. Any changes to working arrangements will be communicated to the person appointed as soon as they become available.

Breaks must be taken according to operational requirements.

In accordance with the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service variations to the established working week or patterns of work will be reasonable and subject to adequate notice.

Other fixed term contract and temporary posts may arise and be filled from a reserve list, these vacancies may comprise of alternative hours of duty and working patterns to those stated above including part-time or job share hours.

Annual leave

Annual leave and extra statutory, bank or public holiday entitlement is calculated in hours/minutes.

A person appointed on the standard full time hours of 37 per week will be entitled to 177.6 hours (24 days) annual leave, plus 88.8 hours (12 days) bank or other holidays.

Annual leave entitlement will be increased by 37 hours (5 days) in the case of officers who have not less than 5 years' continuous service and by a further 22.2 hours (3 days) in the case of officers who have not less than 10 years' continuous service.

Figures in brackets represent the number of days based upon a standard day of 7.4 hrs.

For individuals who do not work the standard full-time hours, annual leave and extra statutory, bank or public holiday entitlement will be calculated on pro-rata basis to their contracted hours, based on the standard full time hours of 37 per week and a standard day of 7.4 hours (i.e. 7 hrs 24 minutes).

Employees are entitled to a holiday with a normal day's pay for each of the statutory, general and public holidays as they occur. Where the balance of the employee's public / bank and statutory holiday entitlement has been exhausted, additional leave taken for public / bank and statutory holidays will be deducted from the employee's annual leave entitlement.

All employees required to work on extra statutory, bank or public holidays will be remunerated in accordance with Part 3, paragraph 2 of the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service.

The leave year commences on 1 April. If an employee starts part way through the annual leave year, the employee will receive annual leave entitlement on a pro rata basis, calculated on the number of days remaining in the current leave year from the first day of employment.

Sick leave

This scheme is intended to supplement Statutory Sick Pay and Incapacity Benefit so as to maintain normal pay during defined periods of absence on account of sickness, disease, accident or assault. Absence in respect of normal sickness is entirely separate from absence through industrial disease, accident or assault arising out of or in the course of employment with a local authority. Periods of absence in respect of one shall not be set off against the other for the purpose of calculating entitlements under the scheme. Employees are entitled to receive sick pay for the following periods:

During first year of service

one month's full pay and (after completing four

months service) two months half pay

During second year of service

two months' full pay, and two months' half pay

During third year of service four months' full pay, and four months' half pay

During fourth and fifth years of service five months' full pay, and five months' half pay


