Job title: Crematorium Technician

Main purpose of job

Responsible to the Cemeteries and Crematorium Manager, through the Senior Crematorium Technician for the efficient and effective delivery of functions relating to The Burial Grounds Regulations 1992 and The Cremation (Belfast) Regulations (Northern Ireland) 1961.

Receive funerals and services showing tact, sympathy, compassion and respect to visitors and maintaining good customer awareness and dignified working relationships with funeral directors, ministers of religion and mourners, thus ensuring an atmosphere of reverence is maintained at all times.

Undertake chapel duties and be responsible for the smooth operation of the Crematorium, as required, for example, checking the daily list of services, assisting in the funeral service, ensuring webcasting/audio visual equipment is switched on and off, playing music and ensuring all areas are maintained, clean and tidy - internally and externally.

Undertake duties involved in the cremation of the dead in accordance with recognised code of practice, for example, administration work, operation of cremator equipment and ensuring that all regulations are being adhered to, to the highest operating standards.

Summary of responsibilities and personal duties

Cremator Duties

1. Undertake the necessary identification checks of the deceased, following all procedures before cremation.

- 2. Operate the cremator and any ancillary equipment within the established principles and guidelines for burial and cremation.
- Understand and have the ability to operate cremators in compliance with all legal protocol and approved standards of operation, for example, ICCM, COTS, CTTS and CPE.
- 4. Assist in maintaining the day-to-day operational standards of the crematorium to ensure the service is delivered to the highest standards and to statutory requirements.
- 5. Deliver the role in an efficient and effective manner in accordance and in compliance with health and safety requirements, policies and risk assessments, e.g., COSHH, manual, handling, and ensure that all accident reporting procedures are appropriately applied.
- 6. Ensure safe operation and routine maintenance of cremators and auxiliary equipment such as fans, smoke indicators and other similar equipment, including minor repairs and identifying and reporting any irregularities with equipment.
- 7. Ensure safe operation, routine maintenance and cleanliness of reducing machine and miscellaneous equipment such as catafalque etc and ensure the cremator room and other areas within the crematorium are kept clean.
- 8. Ensure the appropriate storage of ashes prior to disposal, to check ashes for final disposal, to pack ashes for despatch and to remove metal objects from cremated remains. To dispose of cremated remains as instructed, including the burial and scattering of ashes in the cemetery.
- 9. Ensure that all administration associated with cremations is accurate and completed and to assist with the collation of information for reports, registers etc., as and when required.
- 10. Comply at all times with the Code of Cremation Practice as laid down by the Federation of British Cremation Authorities and the Health and Safety at Work Regulations 1992 and appropriate legislation.

Chapel Duties

11. Clean the chapel, waiting rooms, entrance hall and other ancillary rooms. All wooden surfaces must be dusted and polished daily and floral displays maintained.

- 12. Check the daily list of services and ensure that the chapel is prepared according to the type of service that will be conducted. To set out correctly the times of the services and the names of the deceased onto the daily information board.
- 13. On the arrival of the cortege at the crematorium, to show the family mourners to their seats in the chapel and assist as required with the transfer of the coffin from the hearse to the catafalque.
- 14. Check the name of the coffin plate against that on his or her sheet, to ensure the correct coffin has arrived, before the coffin enters the crematorium.
- 15. Ensure the correct placing of the coffin onto the catafalque by the family or funeral directors.
- 16. Assist with the daily operation of the webcasting equipment for each cremation sermon following the appropriate processes and procedures.
- 17. Assist in the funeral service such as, making short announcements and pressing the committal button at the appropriate time.
- 18. Operate and coordinate different music formats, operate audio visual equipment if requested, to meet the requirements of both the minister and family representatives during the funeral service.
- 19. Escort the mourners from the chapel and crematorium at the end of the service.
- 20. Maintain good relations with Ministers, Funeral Directors, mourners and other visitors to the crematorium.
- 21. Ensure that all public areas are neat and tidy between services so that the individual aspect of every service is maintained, for example, straightening up of hymn books, mopping the entrance hall and lifting indoor / outdoor litter.
- 22. Clean the Book of Remembrance Room on a daily basis and every morning turn the page in the book.

General Duties

- 23. Undertake key-holding duties at the crematorium as and when required.
- 24. Undertake administrative duties, liaising with the bereavement booking office and issuing ashes to customers, as and when required.
- 25. Be available for emergency cover as required.
- 26. Assist the management team to respond to all routine correspondence, enquiries and complaints.

- 27. Undertake periodic stock taking of urns and cremator parts periodically.
- 28. Deputise for the Senior Crematorium Technician in their absence as required.
- 29. Participate in all induction and in-service training provided by Belfast City Council and in the induction and support of all newly appointed staff and other human resource management policies and procedures, as appropriate, including, absence management, disciplinary and grievance procedure.
- 30. Act in accordance with the council and departmental policies and procedures including customer care, equal opportunities, health and safety, safeguarding and any pertinent legislation.
- 31. Undertake the duties in such a way as to enhance and protect the reputation and public profile of the council.
- 32. Undertake such other relevant duties as may from time to time be required.

This job description has been written at a time of significant organisational change and it will be subject to review and amendment as the demands of the role and the organisation evolve. Therefore, the post-holder will be required to be flexible, adaptable and aware that they may be asked to perform tasks, duties and responsibilities which are not specifically detailed in the job description but which are commensurate with the role.

Work planning skills: the ability to effectively plan and prioritise tasks.

Health and safety awareness: a basic understanding of the health and safety responsibilities attached to the post to ensure the safety of other council employees and members of the public.

Belfast City Council is the Data Controller under the UK General Data Protection Regulation (UK GDPR) for the personal data it processes relating to job applicants. Appointment

The appointment will be made by the selection panel, but will be subject to ratification by the director of the relevant department.

There is currently one permanent, full time post.

There may be a reserve list of applicants drawn up for this post which would last for a maximum of 12 months. Should a similar post become vacant within this time, it may be offered to those on the reserve list, in order of merit, without further interview. For generic-type posts, this may include posts in another department. These posts may be either full-time, part-time or job share on a permanent, temporary or fixed-term basis.

If you are offered and you accept a temporary position e.g. a temporary part-time position for 3 months, and another temporary part-time position arises from the same recruitment campaign e.g. for 1 year, regardless of whether or not you are still working in your temporary part-time position, you will not be offered any further temporary part-time position.

However, in certain circumstances, when all relevant applicants on the reserve list for temporary vacancies, full-time or part-time, have been offered opportunities for which they expressed a preference on their application form, and if the timing of the reserve list is still valid and there are still temporary vacancies to fill before the reserve list expires, the council reserves the right to 'revisit' the reserve list in strict order of merit. Remuneration

The salary will be determined by the council in line with that determined by the National Joint Council for Local Government Services, currently Salary Scale 5, SCP 13 to 18, £26,873 - £29,269 per annum, with weekend enhancement and shift allowance (currently under review), where appropriate (in normal circumstances, the starting salary is the minimum point), paid fortnightly by direct payment by the Bankers Automated Clearing System (BACS) to a bank or building society account of your choice.

The council reserves the right to transfer the post-holder onto monthly pay by BACS at any stage in the future without payment.

Location

The person appointed will be based initially in Roselawn Crematorium, 129 Ballygowan Road, Belfast, BT5 7TZ but will be required to work in and, or visit other locations.

Pre-employment checks

Prior to taking up duty the person recommended for appointment must:

- (a) Enter into an agreement which sets out the main terms and conditions of employment.
- (b) Provide evidence of the right to work and reside in the UK via either:
 - a digital identity check via the council's Identity Service Provider (IDSP). To use this
 method, you will need to hold a current UK or Irish biometric passport or passport card.
 or
 - an original full UK birth certificate and original proof of national insurance number (for example, via national insurance card, P45 or payslip etc). No temporary national insurance numbers can be accepted.
 - Individuals who do are unable to provide evidence of their right to work and reside in the UK via either of the methods above, must inform the council and a list of any official alternative documentation will be made available to them.
- (c) Provide details of the bank or building society account to which their salary or wage will be lodged.
- (d) Pass satisfactorily a medical assessment by the council's Occupational Health Service provider.
- (e) Complete a disclosure of family relationships form.
- (f) Complete a disclosure of criminal convictions form, under the Rehabilitation of Offenders (NI) Order 1978. Council policies

The person appointed will be required to comply with all current and future council policies, procedures, guidelines, agreed working practices and any relevant collective agreements incorporated into the contract of employment.

Conditions

The general conditions of service as prescribed from time to time by the National Joint Council for Local Government Services and by the council for its officers shall apply to the appointment and the Single Status Implementation Agreement dated 2007 as renegotiated from time to time is hereby incorporated into the contract of employment.

A copy of the council's Disciplinary Procedure and Grievance Procedure will be issued to all new employees at the council's Induction Course.

Please note, when advised, you will be required for operational reasons to work outside of these hours including on extra statutory, bank and/or public holidays.

In accordance with the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service variations to the established working week or patterns of work will be reasonable and subject to adequate notice.

Annual leave

Annual leave and extra statutory, bank or public holiday entitlement is calculated in hours/minutes.

A person appointed on the standard full time hours of 37 per week will be entitled to 177.6 hours (24 days) annual leave, plus 88.8 hours (12 days) bank or other holidays.

Annual leave entitlement will be increased by 37 hours (5 days) in the case of officers who have not less than 5 years' continuous service and by a further 22.2 hours (3 days) in the case of officers who have not less than 10 years' continuous service.

Figures in brackets represent the number of days based upon a standard day of 7.4 hrs.

For individuals who do not work the standard full-time hours, annual leave and extra statutory, bank or public holiday entitlement will be calculated on pro-rata basis to their contracted hours, based on the standard full time hours of 37 per week and a standard day of 7.4 hours (i.e. 7 hrs 24 minutes).

Employees are entitled to a holiday with a normal day's pay for each of the statutory, general and public holidays as they occur. Where the balance of the employee's public / bank and statutory holiday entitlement has been exhausted, additional leave taken for public / bank and statutory holidays will be deducted from the employee's annual leave entitlement.

All employees required to work on extra statutory, bank or public holidays will be remunerated in accordance with Part 3, paragraph 2 of the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service.

The leave year commences on 1 April. If an employee starts part way through the annual leave year, the employee will receive annual leave entitlement on a pro rata basis, calculated on the number of days remaining in the current leave year from the first day of employment.

Sick leave

This scheme is intended to supplement Statutory Sick Pay and Incapacity Benefit so as to maintain normal pay during defined periods of absence on account of sickness, disease, accident or assault. Absence in respect of normal sickness is entirely separate from absence through industrial disease, accident or assault arising out of or in the course of employment with a local authority. Periods of absence in respect of one shall not be set off against the other for the purpose of calculating entitlements under the scheme. Employees are entitled to receive sick pay for the following periods:

During first year of service one month's full pay and (after completing four

months service) two months half pay

During second year of service two months' full pay, and two months' half pay

During third year of service four months' full pay, and four months' half pay

During fourth and fifth years of service five months' full pay, and five months' half pay

After five years' service six months' full pay, and six months' half pay

Superannuation

The person appointed will automatically become a member of the Local Government Pension Scheme (Northern Ireland) LGPS (NI) in line with scheme regulations. They may opt out of the scheme. However, the council is required to comply with automatic enrolment provisions and will automatically enroll the person appointed at certain times. Appointees (including for casual posts), who do not meet the criteria for immediate automatic enrolment, can opt to join the scheme by contacting Payroll in writing (email payroll@belfastcity.gov.uk). The LGPS (NI) is administered by Northern Ireland Local Government Officers' Superannuation Committee (NILGOSC) (www.nilgosc.org.uk).

Uniform

Uniform clothing will be issued by the relevant department. The wearing of such uniform clothing will be a pre-requisite of appointment and it must only be worn whilst on duty. Only in exceptional circumstances will items be replaced. All items of clothing and other issued equipment will remain the property of the relevant department. Facilities for changing and storage will be available.

Canvassing

Canvassing in any form, oral or written, direct or indirect, will disqualify an applicant for appointment. Candidates can, however, contact the relevant department for further information about the post. The person from the relevant department who provides further information should not be a member of the selection panel.

Notice

The minimum period of notice to be given by an employee shall normally be the ordinary period from one payment of salary or wages to the next.


