Main purpose of job

Responsible to the relevant manager for the provision of an effective support service to facilitate the delivery of key economic development projects and other relevant economic development strategies.

Assist in the development, coordination and delivery of allocated projects, including programming own workload to meet priorities and deadlines.

Assist the Economic Development Officer with the coordination, organisation and delivery of various business and community events and workshop activities.

Undertake regular research into best practice, emerging issues and policy developments in order to support the development and delivery of key projects and programmes of work.

Summary of responsibilities and personal duties

1. Provide an effective support service to unit staff in order to facilitate the delivery of key economic development projects, other relevant economic development strategies and the economic development priorities of the Belfast Agenda.
2. Assist in the development, coordination and delivery of allocated projects or initiatives, including programming own workload to meet priorities and deadlines.
3. Assist in the effective development and application of consistent project standards and methodologies and ensure that appropriate project management processes, procedures and guidelines are adhered to.
4. Effectively control and oversee compliance with eligibility procedures by third party organisations for assigned projects and undertake monitoring visits to third party funded organisations to ensure compliance with Belfast City Council and external funders' requirements.
5. Collate performance and financial data and ensure accurate records are maintained, in order to allow inspection by internal audit and external funders and review by unit management.
6. Support Officers in compiling funding claims to external bodies.
7. Undertake relevant research on economic issues to support the development of key projects and programmes of work, sharing good practice and relevant information.
8. Monitor and maintain up-to-date, relevant information on economic development in Belfast, to support the ongoing development and delivery of the programme of work.
9. Act as the first point of contact for enquiries on economic development projects and associated work, providing information and advice as required and at a level appropriate to the post.
10. Assist with the monitoring of resources and activity and provide regular reports to council and to other appropriate funding bodies.
11. Assist with the development and maintenance of relevant administrative systems including databases and information sources, manipulating data and providing reports when required and maintain project files, in line with council and funder requirements.
12. Liaise with internal, external and other key stakeholders as required, in support of project work and ensure that high standards of service are being consistently delivered.

13. Work as part of the Economic Development team; ensuring a cohesive and collaborative approach to delivery of all interrelated projects and initiatives.
 14. Work with relevant officers and the Marketing and Communications team to plan communication activity for assigned projects in order to support delivery of project KPIs.
 15. Work closely with the Marketing and Communications team to ensure that all relevant communication and engagement activities are promoted across the council's online platforms.
 16. Support the Economic Development team in organising, managing and delivering key business and community events and workshop activities.
 17. Support and work with relevant departmental business support staff in undertaking general project administrative duties related to the programme of work of the unit.
 18. Motivate and manage any staff that may be assigned, to ensure effective service delivery and to be responsible for reviewing and implementing a proper staff training and development programme.
 19. Act in accordance with the council and departmental policies and procedures including customer care; equal opportunities; health and safety; safeguarding and any pertinent legislation.
 20. Participate in all induction and in-service training provided by Belfast City Council and in the induction and support of all newly appointed staff and other human resource management policies and procedures, as appropriate, including absence management, disciplinary and grievance procedure.
 21. Participate as directed in the council's recruitment and selection procedures.
 22. Undertake the duties in such a way as to enhance and protect the reputation and public profile of the council.
 23. Undertake such other relevant duties as may from time to time be required.

Political sensitivity skills: the ability to treat confidential matters with the appropriate discretion and the ability to work with elected representatives with an appreciation of the sensitivities of working in a political environment and an understanding of the operation of local government and the issues it faces.

Project delivery skills: the ability to support the delivery of complex projects and to oversee effective delivery by third party organisations.

Belfast City Council is the Data Controller under the General Data Protection Regulations (GDPR) for the personal data it processes relating to job applicants. Processing data from job applicants allows the council to manage the recruitment process, assess and confirm an applicant's suitability for employment and decide to whom to offer a job. Appointment

The appointment will be made by the selection panel, but will be subject to ratification by the director of the relevant department.

There may be a reserve list of applicants drawn up for this post which would last for a maximum of 12 months. Should a similar post become vacant within this time, it may be offered to those on the reserve list, in order of merit, without further interview. For generic-type posts, this may include posts in another department.

If a similar post does become vacant within this time, it will be offered to candidates on the reserve list in the following way:

1. Candidates will be initially contacted by telephone and **must** respond within three working days to accept or decline the post.
2. Candidates who cannot be contacted by telephone will be contacted by letter and **must** respond by telephone or by return of acceptance form within five working days of the date of the letter.

If candidates do not respond within the above time frames, the post will be offered, in order of merit, to the next person on the reserve list. The names of those candidates who have not responded within the above timeframes will be retained on the reserve list, in order of merit, to be considered for future vacant posts.

This is a 'temporary cover' post until 19 October 2022, subject to review. An existing permanent employee of Belfast City Council will, if successful, be appointed on the basis of undertaking a 'temporary cover' post with the right to return to their substantive post at the conclusion of the 'temporary cover' post. An existing temporary or fixed term contract employee will, if successful, be appointed on the basis of a further temporary or fixed term contract into a 'temporary cover' post but with no automatic right to revert back to their original temporary or fixed term contract post. Similarly, an existing agency assignee will, if successful, be appointed on the basis of a 'temporary cover' post but with no automatic right to revert back to their original agency assignment. Temporary and fixed term contract employees and agency assignees should give consideration to this prior to applying or accepting this post.

Remuneration

The salary will be determined by the council in line with that determined by the National Joint Council for Local Government Services, currently Salary Scale SO1, SCP 23 to 25, £27,741 - £29,577 per annum (in normal circumstances, the starting salary is the minimum point), paid monthly by direct payment by the Bankers Automated Clearing System (BACS) to a bank or building society account of your choice.

Location

The person appointed will be based initially in 9 Adelaide, 9 – 21 Adelaide Street, Belfast but will be required to work in and/or visit other locations.

Please note, given the uncertainty of the ongoing situation with Covid 19 (Coronavirus) and the closure of council buildings the person appointed may be asked, in the first instance, to report to a different location, work from home and/or be reassigned or redeployed to another area of work within the council.

Pre-employment checks

Prior to taking up duty the person recommended for appointment must:

- (i) Complete a disclosure of criminal convictions form, under the Rehabilitation of Offenders (NI) Order 1978. Council policies

The person appointed will be required to comply with all current and future council policies, procedures, guidelines, agreed working practices and any relevant collective agreements incorporated into the contract of employment.

Conditions

The general conditions of service as prescribed from time to time by the National Joint Council for Local Government Services and by the council for its officers shall apply to the appointment and the Single Status Implementation Agreement dated 2007 as renegotiated from time to time is hereby incorporated into the contract of employment.

A copy of the council's Disciplinary Procedure and Grievance Procedure will be issued to all new employees at the council's Induction Course.

Service and hours of duty

The hours of duty are 37 per week, working five days per week, Monday to Friday. Flexible working hours are in operation between 7.30am and 6.30pm, with set core times that the person appointed must be in work. However, the person appointed will be required to start and finish work at specific times that suit the operational needs of the service and they will, when advised, be required to work outside of these hours for operational reasons including on extra statutory, bank and/or public holidays.

In accordance with the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service variations to the established working week or patterns of work will be reasonable and subject to adequate notice.

Annual leave

Annual leave and extra statutory, bank or public holiday entitlement is calculated in hours/minutes.

A person appointed on the standard full time hours of 37 per week will be entitled to 170.2 hours (23 days) annual leave, plus 88.8 hours (12 days) bank or other holidays.

Annual leave entitlement will be increased by 37 hours (5 days) in the case of officers who have not less than 5 years' continuous service and by a further 22.2 hours (3 days) in the case of officers who have not less than 10 years' continuous service.

Figures in brackets represent the number of days based upon a standard day of 7.4 hrs.

For individuals who do not work the standard full-time hours, annual leave and extra statutory, bank or public holiday entitlement will be calculated on pro-rata basis to their contracted hours, based on the standard full time hours of 37 per week and a standard day of 7.4 hours (i.e. 7 hrs 24 minutes).

Employees are entitled to a holiday with a normal day's pay for each of the statutory, general and public holidays as they occur. Where the balance of the employee's public / bank and statutory holiday entitlement has been exhausted, additional leave taken for public / bank and statutory holidays will be deducted from the employee's annual leave entitlement.

All employees required to work on extra statutory, bank or public holidays will be remunerated in accordance with Part 3, paragraph 2 of the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service.

The leave year commences on 1 April. If an employee starts part way through the annual leave year, the employee will receive annual leave entitlement on a pro rata basis, calculated on the number of days remaining in the current leave year from the first day of employment.

Sick leave

This scheme is intended to supplement Statutory Sick Pay and Incapacity Benefit so as to maintain normal pay during defined periods of absence on account of sickness, disease, accident or assault. Absence in respect of normal sickness is entirely separate from absence through industrial disease, accident or assault arising out of or in the course of employment with a local authority. Periods of absence in respect of one shall not be set off against the other for the purpose of calculating entitlements under the scheme. Employees are entitled to receive sick pay for the following periods:

During first year of service	one month's full pay and (after completing four months service) two months half pay
During second year of service	two months' full pay, and two months' half pay
During third year of service	four months' full pay, and four months' half pay
During fourth and fifth years of service	five months' full pay, and five months' half pay
After five years' service	six months' full pay, and six months' half pay

Superannuation

The person appointed will automatically become a member of the Local Government Pension Scheme (Northern Ireland) LGPS (NI) in line with scheme regulations. They may opt out of the scheme. However, the council is required to comply with automatic enrolment provisions and will automatically enrol the person appointed at certain times. The LGPS (NI) is administered by Northern Ireland Local Government Officers' Superannuation Committee (NILGOSC) (www.nilgosc.org.uk).

Canvassing

Canvassing in any form, oral or written, direct or indirect, will disqualify an applicant for appointment. Candidates can, however, contact the relevant department for further information about the post. The person from the relevant department who provides further information should not be a member of the selection panel.

Notice

The minimum period of notice to be given by an employee shall normally be the ordinary period from one payment of salary or wages to the next.
