## Main purpose of job

Responsible to the Neighbourhood and Development Manger through the Leisure Development Manager for the development and promotion of physical activity and sport to enhance and create sporting opportunities for all, using the Lifelong Involvement in Sports and Physical Activity model.

Assist the Leisure Development Manager in the development and Implementation of a Physical Activity and Sports Development Strategy.

Develop partnerships with organisations to achieve the objectives of the City and Neighbourhood Services Department, through participation in project teams and consultative groups as necessary.

## Summary of responsibilities and personal duties

1. To be responsible to the Leisure Development Manager for the development, implementation, and promotion of a physical activity and sports development strategy, business plan and associated programme ensuring the inclusive involvement of the community.
2. To represent the Leisure Development Manager as and when requested within the post holder's sphere of responsibility.
3. To identify and implement opportunities for sports development, arising from international, national, regional and local sporting events.
4. To manage projects assigned by the Leisure Development Manager and where appropriate to represent Belfast City Council within own sphere of responsibility.
5. To identify and develop effective partnership to deliver sectional sporting initiatives and stimulate the involvement and sustained participation of under-represented groups.
6. To advise and support clubs and community organisations on appropriate structures, governance, facilities and external funding using best practice principles.
7. To support departmental and interdepartmental managers with the development of new facilities, activities and programmes.
8. To organise and promote club activities, competitions, workshops, and events within departmental facilities and other civic buildings.
9. To assist the Leisure Development Manager and other managers to organise and promote schemes, courses and other events within departmental facilities.
10. To enhance the reputation of the city through effective promotion of all relevant activities in liaison with departmental and corporate communications staff.
11. To be responsible for organising a programme of events under the direction of the Leisure Development Manager and to liaise with relevant stakeholders.
12. To create, research and introduce new and innovative programmes to increase participation in health, sport and physical activities.
13. To seek, create and develop partnerships with funding organisations to help sustain the Sports Development Programme.
14. To monitor and control the budget allocated to the Sports Development Programme within the Leisure Development Unit.

15. To be responsible for the appraisal of grant and funding applications, assessing eligibility as per agreed criteria, exercising judgements and making recommendations regarding appropriateness of applications and level of funding awarded.
  16. To ensure ongoing monitoring and evaluation of sports development initiatives against agreed performance targets and providing timely statistics and reports for elected members and departmental management teams.
  17. To assist in drawing up necessary tenders and quotations in liaison with departmental procurement officer and to manage external suppliers when necessary.
  18. To motivate and manage any staff that may be assigned, to the post holder to ensure effective service delivery and to be responsible for reviewing and implementing a proper staff training and development programme.
  19. To participate in all induction and in-service training provided by Belfast City Council and in the induction and support of all newly appointed staff and other human resource management policies and procedures, as appropriate, including, absence management, disciplinary and grievance procedure.
  20. To participate as directed in the council's recruitment and selection procedures.
  21. To act in accordance with the council and departmental policies and procedures including customer care, equal opportunities, health and safety, safeguarding and any pertinent legislation.
  22. To undertake the duties in such a way as to enhance and protect the reputation and public profile of the council.
  23. To undertake such other relevant duties as may from time to time be required.

**Financial awareness:** an understanding of budget preparation and limitation with the ability to monitor expenditure and take remedial action as required.

**Performance management:** an understanding of how to deliver a value for money service via performance management systems and procedures including performance indicators, benchmarking and quality assurance methodologies.

#### **Job applicant privacy notice**

Belfast City Council is the Data Controller under the UK General Data Protection Regulation (UK GDPR) for the personal data it processes relating to job applicants. Processing data from job applicants allows the council to manage the recruitment process, assess and confirm an applicant's suitability for employment and decide to whom to offer a job. It may also need to process data from job applicants to respond to and defend against legal claims.

If you apply for this job, you will be consensually providing your personal data to the council whose lawful basis for processing it is for the performance of a task carried out in the public interest or in the exercise of official authority.

The council will collect a range of information about you, including:

### **Appointment**

The appointment will be made by the selection panel, but will be subject to ratification by the director of the relevant department.

There may be a reserve list of applicants drawn up for this post which would last for a maximum of 12 months. Should a similar post become vacant within this time, it may be offered to those on the reserve list, in order of merit, without further interview. For generic-type posts, this may include posts in another department.

If you are offered and you accept a temporary position e.g. a temporary part-time position for 3 months, and another temporary part-time position arises from the same recruitment campaign e.g. for 1 year, regardless of whether or not you are still working in your temporary part-time position, you will not be offered any further temporary part-time position. However, in certain circumstances, when all relevant applicants on the reserve list for temporary vacancies, full-time or part-time, have been offered opportunities for which they expressed a preference on their application form, and if the timing of the reserve list is still valid and there are still temporary vacancies to fill before the reserve list expires, the council reserves the right to 'revisit' the reserve list in strict order of merit. ### **Remuneration**

The salary will be determined by the council in line with that determined by the National Joint Council for Local Government Services, currently Salary Scale PO1, SCP 27 to 30, £33,820 - £36,298 per annum (in normal circumstances, the starting salary is the minimum point), paid monthly by direct payment by the Bankers Automated Clearing System (BACS) to a bank or building society account of your choice.

### **Location**

The person appointed will be based initially in the Cecil Ward Building, 4 – 10 Linenhall Street, Belfast but will be required to work in and/or visit other locations.

### **Pre-employment checks**

Prior to taking up duty the person recommended for appointment must:

### **Council policies**

The person appointed will be required to comply with all current and future council policies, procedures, guidelines, agreed working practices and any relevant collective agreements incorporated into the contract of employment.

### **Conditions**

The general conditions of service as prescribed from time to time by the National Joint Council for Local Government Services and by the council for its officers shall apply to the appointment and the Single Status Implementation Agreement dated 2007 as renegotiated from time to time is hereby incorporated into the contract of employment.

*A copy of the council's Disciplinary Procedure and Grievance Procedure will be issued to all new employees at the council's Induction Course.*

### **Service and hours of duty**

The hours of duty are 37 per week, working five days per week, Monday to Friday. Flexible working hours are in operation between 7.30am and 6.30pm, with set core times that the person appointed must be in work. However, the person appointed will be required to start and finish work at specific times that suit the operational needs of the service and they will, when advised, be required to work outside of these hours for operational reasons including on extra statutory, bank and/or public holidays.

In accordance with the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service variations to the established working week or patterns of work will be reasonable and subject to adequate notice.

## **Annual leave**

Annual leave and extra statutory, bank or public holiday entitlement is calculated in hours/minutes.

A person appointed on the standard full time hours of 37 per week will be entitled to 170.2 hours (23 days) annual leave, plus 88.8 hours (12 days) bank or other holidays.

Annual leave entitlement will be increased by 37 hours (5 days) in the case of officers who have not less than 5 years' continuous service and by a further 22.2 hours (3 days) in the case of officers who have not less than 10 years' continuous service.

Figures in brackets represent the number of days based upon a standard day of 7.4 hrs.

For individuals who do not work the standard full-time hours, annual leave and extra statutory, bank or public holiday entitlement will be calculated on pro-rata basis to their contracted hours, based on the standard full time hours of 37 per week and a standard day of 7.4 hours (i.e. 7 hrs 24 minutes).

Employees are entitled to a holiday with a normal day's pay for each of the statutory, general and public holidays as they occur. Where the balance of the employee's public / bank and statutory holiday entitlement has been exhausted, additional leave taken for public / bank and statutory holidays will be deducted from the employee's annual leave entitlement.

All employees required to work on extra statutory, bank or public holidays will be remunerated in accordance with Part 3, paragraph 2 of the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service.

The leave year commences on 1 April. If an employee starts part way through the annual leave year, the employee will receive annual leave entitlement on a pro rata basis, calculated on the number of days remaining in the current leave year from the first day of employment.

## **Sick leave**

This scheme is intended to supplement Statutory Sick Pay and Incapacity Benefit so as to maintain normal pay during defined periods of absence on account of sickness, disease, accident or assault. Absence in respect of normal sickness is entirely separate from absence through industrial disease, accident or assault arising out of or in the course of employment with a local authority. Periods of absence in respect of one shall not be set off against the other for the purpose of calculating entitlements under the scheme. Employees are entitled to receive sick pay for the following periods:

During first year of service	one month's full pay and (after completing four months service) two months half pay
During second year of service	two months' full pay, and two months' half pay
During third year of service	four months' full pay, and four months' half pay
During fourth and fifth years of service	five months' full pay, and five months' half pay
After five years' service	six months' full pay, and six months' half pay

## **Superannuation**

The person appointed will automatically become a member of the Local Government Pension Scheme (Northern Ireland) LGPS (NI) in line with scheme regulations. They may opt out of the scheme. However, the council is required to comply with automatic enrolment provisions and will automatically enrol the person appointed at certain times. The LGPS (NI) is administered by Northern Ireland Local Government Officers' Superannuation Committee (NILGOSC) ([www.nilgosc.org.uk](http://www.nilgosc.org.uk)).

**Car user**

This job will require the postholder to carry out council duties in all areas and locations across the city and beyond. To do this, the postholder must have a full, current driving licence and have their own transport available for official council business. For this, the postholder will be reimbursed at the appropriate mileage rate, in accordance with the council's Car User Policy if they use their own car.

**Canvassing**

Canvassing in any form, oral or written, direct or indirect, will disqualify an applicant for appointment. Candidates can, however, contact the relevant department for further information about the post. The person from the relevant department who provides further information should not be a member of the selection panel.

**Notice**

The minimum period of notice to be given by an employee shall normally be the ordinary period from one payment of salary or wages to the next.

Belfast City Council may terminate an employee's employment with the council by giving the following period of notice:
