Reporting to the Enterprise and Business Growth Manager, the post will be responsible for:

Developing, leading and coordinating key economic development projects within the Enterprise Framework and contributing to other relevant economic development strategies and policies which stimulate business growth, promote entrepreneurial activity and support local business development and investment.

Managing assigned programmes of work which support the development and growth of the city and the economy, and which contribute to the delivery of the council's strategic priorities and the Belfast Agenda within agreed strategic areas of focus.

Engaging directly with businesses to understand growth challenges and development opportunities and bringing forward initiatives to support business growth.

Developing and maintaining effective partnerships with other organisations in both the public and private sectors to ensure a strategic, sustained and coordinated approach to economic development in the city.

Summary of responsibilities and personal duties

1. Contribute to the design, development and implementation of the Enterprise Framework and other relevant economic development strategies, taking account of wider departmental and corporate objectives, including the ongoing delivery of the Belfast Agenda and the Belfast Region City Deal.

 local businesses, support business development and entrepreneurial activity, develop the

- 3. Undertake relevant procurement exercises and effectively contract manage allocated projects in line with agreed outcomes and ensure appropriate financial and project management by project delivery agents.
- 4. Build the business case for investment in a range of local initiatives and projects that stimulate business growth and make a positive difference to businesses and residents across the city, leading and managing these as required.
- 5. Develop a range of targeted initiatives based on business engagement and market place intelligence, in order to create business development opportunities and stimulate new and existing growth and investment within the city.
- 6. Effectively engage and work collaboratively with local businesses and a range of other key stakeholders to identify their needs, build sustainable working relationships and address barriers to enterprise activity and business growth.
- 7. Identify, develop and maintain strategic partnerships with key agencies and individuals in the community, public, statutory and private sector in order to ensure a targeted and coordinated approach to economic development in the city.
- 8. Identify and pursue opportunities to work collaboratively with other Enterprise and Business Growth Officers, and with colleagues across the department and wider organisation in order to maximise the council's contribution to economic development in the city.
- 9. Develop and cultivate local, national and international partnerships to share experience and best practice, develop relationships and exploit opportunities for the economic development of the Belfast City Council area.
- 10. Develop and support, in partnership with key stakeholders, city-wide economic regeneration initiatives to act as a catalyst for investment and encourage business start-up and growth.
- 11. Commission and carry out research which will track, monitor and evaluate the performance of the economy and will assist in the identification of appropriate mechanisms and initiatives to support the development of the city.
- 12. Draft reports, corporate briefings, policy responses and speeches for council members and officers and prepare committee reports.
- 13. Influence policy and strategy development both within council and with external agencies in order to support the delivery of key strategic priorities.

14. Work with the Marketing and Communications team to develop and manage appropriate forms of communication in order to promote the work of the team including website, promotional materials, newsletters and press briefings.

- 15. Identify and attract funding to deliver initiatives to support the economic development of the city and undertake the necessary applications and business cases required to access these resources.
- 16. Implement effective monitoring, financial and administrative procedures pertaining to local government and external funder requirements
- 17. Represent Belfast City Council on all appropriate partnerships, strategic groups, advisory committees as required.
- 18. Represent the Enterprise and Business Growth Manager as required.
- 19. Organise events, conferences, exhibitions, visit programmes and other promotional activities.
- 20. Participate as directed in the council's selection interview procedure.
- 21. Act in accordance with the council and departmental policies and procedures including customer care, equal opportunities, health and safety, safeguarding and any pertinent legislation.
- 22. Participate in induction and in-service training provided by Belfast City Council and in the induction and support of all newly appointed staff and other human resource management procedures as appropriate.
- 23. Undertake the duties in such a way as to enhance and protect the reputation and public profile of the council.
- 24. Undertake such relevant duties as may from time to time be required.

Appointment

There is currently one permanent, full time post.

The appointment will be made by the selection panel, but will be subject to ratification by the director of the relevant department.

There may be a reserve list of applicants drawn up for this post which would last for a maximum of 12 months. Should a similar post become vacant within this time, it may be offered to those on the reserve list, in order of merit, without further interview. For generic-type posts, this may include posts in another department. These posts may be either full-time or part-time on a permanent, temporary or fixed-term basis.

If a similar post does become vacant within this time, it will be offered to candidates on the reserve list in the following way:

Location

The person appointed will be based initially in 9 Adelaide, 9 - 21 Adelaide Street, Belfast but will be required to work in and/or visit other locations.

Council policies

The person appointed will be required to comply with all current and future council policies, procedures, guidelines, agreed working practices and any relevant collective agreements incorporated into the contract of employment.

Conditions

The general conditions of service as prescribed from time to time by the National Joint Council for Local Government Services and by the council for its officers shall apply to the appointment and the Single Status Implementation Agreement dated 2007 as renegotiated from time to time is hereby incorporated into the contract of employment. A copy of the council's Disciplinary Procedure and Grievance Procedure will be issued to all new employees at the council's Induction Course.

Service and hours of duty

The hours of duty are 37 per week, working five days per week, Monday to Friday. Flexible working hours are in operation between 7.30am and 6.30pm, with set core times that the person appointed must be in work. However, the person appointed will be required to start and finish work at specific times that suit the operational needs of the service and she/he will, when advised, be required to work outside of these hours for operational reasons including on extra statutory, bank and/or public holidays.

In accordance with the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service variations to the established working week or patterns of work will be reasonable and subject to adequate notice.

Annual leave

Annual leave and extra statutory, bank or public holiday entitlement is calculated in hours/minutes.

A person appointed on the standard full time hours of 37 per week will be entitled to 170.2 hours (23 days) annual leave, plus 88.8 hours (12 days) bank or other holidays.

Annual leave entitlement will be increased by 37 hours (5 days) in the case of officers who have not less than 5 years' continuous service and by a further 22.2 hours (3 days) in the case of officers who have not less than 10 years' continuous service.

Figures in brackets represent the number of days based upon a standard day of 7.4 hrs.

For individuals who do not work the standard full-time hours, annual leave and extra statutory, bank or public holiday entitlement will be calculated on pro-rata basis to their contracted hours, based on the standard full time hours of 37 per week and a standard day of 7.4 hours (i.e. 7 hrs 24 minutes).

Employees are entitled to a holiday with a normal day's pay for each of the statutory, general and public holidays as they occur. Where the balance of the employee's public / bank and statutory holiday entitlement has been exhausted, additional leave taken for public / bank and statutory holidays will be deducted from the employee's annual leave entitlement.

All employees required to work on extra statutory, bank or public holidays will be remunerated in accordance with Part 3, paragraph 2 of the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service.

The leave year commences on 1 April. If an employee starts part way through the annual leave year, the employee will receive annual leave entitlement on a pro rata basis, calculated on the number of days remaining in the current leave year from the first day of employment.

Sick leave

This scheme is intended to supplement Statutory Sick Pay and Incapacity Benefit so as to maintain normal pay during defined periods of absence on account of sickness, disease, accident or assault. Absence in respect of normal sickness is entirely separate from absence through industrial disease. accident or assault arising out of or in the course of employment with a local authority. Periods of absence in respect of one shall not be set off against the other for the purpose of calculating entitlements under the scheme. Employees are entitled to receive sick pay for the following periods:

During first year of service one month's full pay and (after completing four

months service) two months half pay

two months' full pay, and two months' half pay During second year of service

During third year of service four months' full pay, and four months' half pay

During fourth and fifth years of service five months' full pay, and five months' half pay

Superannuation

The person appointed will automatically become a member of the Local Government Pension Scheme (Northern Ireland) LGPS (NI) in line with scheme regulations. He or she may opt out of the scheme. However, the council is required to comply with automatic enrolment provisions and will automatically enrol the person appointed at certain times. The LGPS (NI) is administered by Northern Ireland Local Government Officers' Superannuation Committee (NILGOSC) (www.nilgosc.org.uk).
