Main purpose of job

To be responsible to the Functions and Exhibition Officer for:-

- assisting with the effective organisation and management of civic and non-civic functions in the council's various function rooms, grounds and other areas;
- assisting in the provision of an efficient public and private tours service, including the supervision and deployment of tour guides;
- assisting the management and control of the City Hall exhibition areas; and
- assisting in the provision of appropriate customer support services for visitors to the civic offices.

Summary of responsibilities and personal duties

- 1. To deputise for the Functions and Exhibition Officer as required, within the postholder's sphere of responsibility.
- 2. To assist as required in ensuring that functions in all of the prestige rooms and other areas within the City Hall and grounds are properly and effectively organised, equipped and hosted, in line with organisers' requirements.
- 3. To assist in ensuring the effective co-ordination and scheduling of the security, cleaning, catering, staffing, safety, set-up and dismantling of the council's main function rooms for the purposes of hosting civic and non-civic events.
- 4. To ensure that the Artifax system (or any replacement) is updated and that the relevant function data is entered in an accurate and timely manner.
- 5. To assist with the management and administration of the delegated authority processes surrounding requests for use of the City Hall or grounds (including the cobbled area) and liaison with all partners and customers in this regard.
- 6. To assist in the planning and provision of a high-quality public and private City Hall tours service.
- 7. To be responsible for the planning of the work of the tours service and for the supervision and deployment of the tour guides and casual staff.
- 8. To liaise with Lord Mayor's Office to arrange tours for all visitors to the council's civic dignitaries.
- 9. To be responsible for the update and maintenance of the tour booking system and to keep new developments under review.
- 10. To assist with the administration of the City Hall's artefacts and artwork collections, including display, cataloguing and security.
- 11. To assist with the development, promotion and implementation of marketing initiatives relative to the function management service, tours service, exhibition facilities and information room, including specialist information for publication and media use.
- 12. To assist with the day to day management and administration of the City Hall exhibition and information areas.
- 13. To assist in ensuring that the feature LED lighting system at City Hall is programmed and deployed to optimal effect for all approved functions and events.
- 14. To undertake research as directed, and to take part in working groups, project teams, consultative and other groups as required.

- 15. To undertake staff training and to assist with the review and implementation of staff training and development plans.
- 16. To prepare statistics in relation to the work of the unit as required.
- 17. To assist in the establishment of safe systems of work, and to ensure that all work is carried out with due regard to health and safety legislation and best practice.
- 18. To assist with the general administrative work of the unit and to carry out any other relevant duties as assigned.
- 19. To motivate and manage any staff that may be assigned to the post holder to ensure effective service delivery and to be responsible for reviewing and implementing a proper staff training and development programme.
- 20. To participate in all induction and in-service training provided by Belfast City Council and in the induction and support of all newly appointed staff and other human resource management policies and procedures, as appropriate, including, absence management, disciplinary and grievance procedure.
- 21. To participate as directed in the Council's recruitment and selection procedures.
- 22. To act in accordance with the council and departmental policies and procedures including customer care, equal opportunities, health and safety, safeguarding and any pertinent legislation.
- 23. To undertake the duties in such a way as to enhance and protect the reputation and public profile of the council.
- 24. To undertake such other relevant duties as may from time to time be required.

This job description has been written at a time of significant organisational change and it will be subject to review and amendment as the demands of the role and the organisation evolve. Therefore, the post-holder will be required to be flexible, adaptable and aware that they may be asked to perform tasks, duties and responsibilities which are not specifically detailed in the job description but which are commensurate with the role.

Belfast City Council is the Data Controller under the General Data Protection Regulations (GDPR) for the personal data it processes relating to job applicants. Appointment

The appointment will be made by the selection panel, but will be subject to ratification by the director of the relevant department.

There may be a reserve list of applicants drawn up for this post which would last for a maximum of 12 months. Should a similar post become vacant within this time, it may be offered to those on the reserve list, in order of merit, without further interview. For generic-type posts, this may include posts in another department. These posts may be either full-time, part-time or job share on a permanent or temporary basis.

If you are offered and you accept a temporary position e.g. a temporary part-time position for 3 months, and another temporary part-time position arises from the same recruitment campaign e.g. for 1 year, regardless of whether or not you are still working in your temporary part-time position, you will not be offered any further temporary part-time position.

Remuneration

The salary will be determined by the council in line with that determined by the National Joint Council for Local Government Services, currently Salary Scale 6, SCP 18 to 22, £24,982 - £27,041 per annum (in normal circumstances, the starting salary is the minimum point), paid monthly by direct payment by the Bankers Automated Clearing System (BACS) to a bank or building society account of your choice.

Location

The person appointed will be based initially in the City Hall, Belfast but will be required to work in and/or visit other locations.

Please note, given the uncertainty of the ongoing situation with Covid 19 (Coronavirus) and the closure of council buildings, you may be asked, in the first instance, to report to a different location, work from home and/or be reassigned or redeployed to another area of work within the council.

Pre-employment checks

Prior to taking up duty the person recommended for appointment must:

- (a) Enter into an agreement which sets out the main terms and conditions of employment.

Council policies

The person appointed will be required to comply with all current and future council policies, procedures, guidelines, agreed working practices and any relevant collective agreements incorporated into the contract of employment.

Conditions

The general conditions of service as prescribed from time to time by the National Joint Council for Local Government Services and by the council for its officers shall apply to the appointment.

A copy of the council's Disciplinary Procedure and Grievance Procedure will be issued to all new employees at the council's Induction Course.

Please note if you are an applicant with previous local authority service in England, Scotland, Wales etc., you are advised to clarify your particular situation with regard to the continuity of this service, prior to accepting an offer of appointment from Belfast City Council.

Service and hours of duty

The hours of duty are 37 per week, working five days per week, Monday to Friday. Flexible working hours are in operation between 7.30am and 6.30pm, with set core times that the person appointed must be in work. However, the person appointed will be required to start and finish work at specific times that suit the operational needs of the service and they will, when advised, be required to work outside of these hours for operational reasons including on extra statutory, bank and/or public holidays.

In accordance with the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service variations to the established working week or patterns of work will be reasonable and subject to adequate notice.

Annual leave

Annual leave and extra statutory, bank or public holiday entitlement is calculated in hours/minutes.

A person appointed on the standard full time hours of 37 per week will be entitled to 170.2 hours (23 days) annual leave, plus 88.8 hours (12 days) bank or other holidays.

Annual leave entitlement will be increased by 37 hours (5 days) in the case of officers who have not less than 5 years' continuous service and by a further 22.2 hours (3 days) in the case of officers who have not less than 10 years' continuous service.

Figures in brackets represent the number of days based upon a standard day of 7.4 hrs.

For individuals who do not work the standard full-time hours, annual leave and extra statutory, bank or public holiday entitlement will be calculated on pro-rata basis to their contracted hours, based on the standard full time hours of 37 per week and a standard day of 7.4 hours (i.e. 7 hrs 24 minutes).

Employees are entitled to a holiday with a normal day's pay for each of the statutory, general and public holidays as they occur. Where the balance of the employee's public / bank and statutory holiday entitlement has been exhausted, additional leave taken for public / bank and statutory holidays will be deducted from the employee's annual leave entitlement.

All employees required to work on extra statutory, bank or public holidays will be remunerated in accordance with Part 3, paragraph 2 of the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service.

The leave year commences on 1 April. If an employee starts part way through the annual leave year, the employee will receive annual leave entitlement on a pro rata basis, calculated on the number of days remaining in the current leave year from the first day of employment.

Sick leave

This scheme is intended to supplement Statutory Sick Pay and Incapacity Benefit so as to maintain normal pay during defined periods of absence on account of sickness, disease, accident or assault. Absence in respect of normal sickness is entirely separate from absence through industrial disease, accident or assault arising out of or in the course of employment with a local authority. Periods of absence in respect of one shall not be set off against the other for the purpose of calculating entitlements under the scheme. Employees are entitled to receive sick pay for the following periods:

During first year of service	one month's full pay and (after completing four months service) two months half pay
During second year of service	two months' full pay, and two months' half pay
During third year of service	four months' full pay, and four months' half pay
During fourth and fifth years of service	five months' full pay, and five months' half pay

After five years' service

Superannuation

The person appointed will automatically become a member of the Local Government Pension Scheme (Northern Ireland) LGPS (NI) in line with scheme regulations. They may opt out of the scheme. However, the council is required to comply with automatic enrolment provisions and will automatically enrol the person appointed at certain times. The LGPS (NI) is administered by Northern Ireland Local Government Officers' Superannuation Committee (NILGOSC) (www.nilgosc.org.uk).

Canvassing

Canvassing in any form, oral or written, direct or indirect, will disqualify an applicant for appointment.
