Main purpose of job

The post-holder will report to the Director of Organisational City and Organisational strategy through the appropriate manager and will be responsible for:

- Acting as an area champion on behalf of community planning partners, strategically
 connecting existing initiatives in a more coherent way and co-designing new priorities and
 projects, which contribute towards the achievement of strategic objectives jointly set by
 community planning partners as part of the Wider University and Lower Ormeau Intervention.
- Be responsible for effective community engagement, relationship building and partnership working, including the establishment of a new community involvement model, and the codesign, co-ordination, management, and implementation of an integrated multi-agency intervention plan that meets community needs and solves local problems.
- Assisting with the provision of quality support and assurance to political and senior officer leadership on the delivery of the Wider University and Lower Ormeau Intervention, and
- Managing all assigned staff and project teams to ensure to delivery of all projects and initiatives within the Wider University and Lower Ormeau area.

The post holder will represent the Director of Organisational City and Organisational Strategy / Portfolio Manager, as may be required, on matters within the post's sphere of responsibility.

Summary of responsibilities and personal duties

1. Be an area champion on behalf of community planning partners, strategically connecting existing initiatives in a more coherent way, and co-designing new priorities and projects, which contribute towards the achievement of strategic objectives jointly set by community planning partners as part of the Wider University and Lower Ormeau Intervention.

- 2. Identify and develop strong partnerships and working relationships with statutory and community partners to improve the effectiveness and efficiency of existing projects, and to co-design new initiatives, so as to meet local need better, support local problem solving and to develop an integrated intervention plan.
- 3. Manage and co-ordinate the development of an inter-agency intervention plan aligned with the principles of community planning, namely; adding clear value and collaborative gain, impactful for communities delivering tangible outcomes, developed with communities, intelligence led and jointly resourced
- 4. Support the establishment and management of appropriate governance structures, including a new community involvement model, for programmes or projects as they emerge, ensuring all technical standards, systems and processes are adhered to.
- 5. Identify synergies and interdependencies between programmes and projects and highlight and report opportunities to maximise delivery and value for money.
- 6. Build and maintain programme and project plan(s) and provide effective leadership and management to deliver stated objectives. Identify and set appropriate programme and project controls.
- 7. Monitor and report against programme and project milestones and provide assurance on delivery through agreed governance structures, including senior officers, community planning partners, elected members and/or other stakeholders as may be appropriate.
- 8. Assist in the collation and analysis of data and evidence to inform priorities and the production of timely reports, briefings, performance management and financial reports and to attend appropriate programme board, community planning and committee meetings as and when required.
- 9. Identifying new and emerging funding opportunities or opportunities to realign existing resources to achieve better outcomes, managing associated budgets as required and ensuring value for money.
- 10. Apply a proactive approach to unblocking problems and barriers in partnership with stakeholders to deliver solutions that keep projects on track.
- 11. Review and quality assure programme and project risk management arrangements, monitoring and reporting on risks and issues, developing mitigating actions and escalating as appropriate.
- 12. Ensure that delivery requirements are met consistently and effectively throughout the programme and project lifecycles and that all financial, legal, procurement, design and other technical inputs for each programme are fit for purpose and in line with appropriate regulations, policies and agreed standards.

13. Develop and implement effective communication strategies in collaboration with Marketing and Communications to ensure that all necessary information is cascaded.

- 14. Understand programme and project management standards and client requirements and help support the development of a consistent approach to building programme and project management capacity within council and community planning partners.
- 15. Ensuring all policy development, consultations and frameworks comply with the council's statutory duties under Section 75 of the Northern Ireland Act 1998 and other applicable legislation and the council's Equality Scheme.
- 16. Motivate and manage any staff, that may be assigned to the post holder to ensure effective service delivery and to be responsible for reviewing and implementing a proper staff training and development programme.
- 17. Participate in all induction and in-service training provided by Belfast City Council and in the induction and support of all newly appointed staff and other human resource management policies and procedures, as appropriate, including, absence management, disciplinary and grievance procedure.
- 18. Participate as directed in the council's recruitment and selection procedures.
- 19. Act in accordance with the council and departmental policies and procedures including customer care, equal opportunities, health and safety, safeguarding and any pertinent legislation.
- 20. Undertake the duties in such a way as to enhance and protect the reputation and public profile of the council.
- 21. Undertake such other relevant duties as may from time to time be required.

Belfast City Council is the Data Controller under the UK General Data Protection Regulation (UK GDPR) for the personal data it processes relating to job applicants. Processing data from job applicants allows the council to manage the recruitment process, assess and confirm an applicant's suitability for employment and decide to whom to offer a job. Appointment

The appointment will be made by the selection panel, but will be subject to ratification by the director of the relevant department.

There may be a reserve list of applicants drawn up for this post which would last for a maximum of 12 months. Should a similar post become vacant within this time, it may be offered to those on the reserve list, in order of merit, without further interview. For generic-type posts, this may include posts in another department.

If a similar post does become vacant within this time, it will be offered to candidates on the reserve list in the following way:

- 1. Candidates will be initially contacted by telephone and **must** respond within three working days to accept or decline the post.
- Candidates who cannot be contacted by telephone will be contacted by letter and must respond by telephone or by return of acceptance form within five working days of the date of the letter.

If candidates do not respond within the above time frames, the post will be offered, in order of merit, to the next person on the reserve list. The names of those candidates who have not responded within the above timeframes will be retained on the reserve list, in order of merit, to be considered for future vacant posts.

This is a 'temporary project' post for 12 months, subject to review. An existing permanent employee of Belfast City Council will, if successful, be appointed on the basis of undertaking a 'temporary project' post with the right to return to their substantive post at the conclusion of the 'temporary project' post. An existing temporary or fixed term contract employee will, if successful, be appointed on the basis of a further temporary or fixed term contract into a 'temporary project' post but with no automatic right to revert back to their original temporary or fixed term contract post. Similarly, an existing agency assignee will, if successful, be appointed on the basis of a 'temporary project' post but with no automatic right to revert back to their original agency assignment. Temporary and fixed term contract employees and agency assignees should give consideration to this prior to applying or accepting this post.

Remuneration

The salary will be determined by the council in line with that determined by the National Joint Council for Local Government Services, currently Salary Scale PO6, SCP 41 to 44, £47,573 - £50,608 per annum (in normal circumstances, the starting salary is the minimum point), paid monthly by direct payment by the Bankers Automated Clearing System (BACS) to a bank or building society account of your choice.

Location

The person appointed will be based initially in City Hall but will be required to work in and/or visit other locations.

Pre-employment checks

Prior to taking up duty the person recommended for appointment must:

- (a) Enter into an agreement which sets out the main terms and conditions of employment.
- (b) Provide evidence of the right to work and reside in the UK via either:

- (f) Pass satisfactorily a medical assessment by the council's Occupational Health Service provider.
- (g) Complete a disclosure of family relationships form.
- (h) Complete a disclosure of criminal convictions form, under the Rehabilitation of Offenders (NI) Order 1978. After pre-employment checks are complete, an applicant must formally accept and commence employment in this post within four weeks.

Council policies

The person appointed will be required to comply with all current and future council policies, procedures, guidelines, agreed working practices and any relevant collective agreements incorporated into the contract of employment.

Conditions

The general conditions of service as prescribed from time to time by the National Joint Council for Local Government Services and by the council for its officers shall apply to the appointment and the Single Status Implementation Agreement dated 2007 as renegotiated from time to time is hereby incorporated into the contract of employment.

A copy of the council's Disciplinary Procedure and Grievance Procedure will be issued to all new employees at the council's Induction Course.

Service and hours of duty

The hours of duty are 37 per week, working five days per week, Monday to Friday. Flexible working hours are in operation between 7.30am and 6.30pm, with set core times that the person appointed must be in work. However, the person appointed will be required to start and finish work at specific times that suit the operational needs of the service and they will, when advised, be required to work outside of these hours for operational reasons including on extra statutory, bank and/or public holidays.

In accordance with the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service variations to the established working week or patterns of work will be reasonable and subject to adequate notice.

Annual leave

Annual leave and extra statutory, bank or public holiday entitlement is calculated in hours/minutes.

A person appointed on the standard full time hours of 37 per week will be entitled to 177.6 hours (24 days) annual leave, plus 88.8 hours (12 days) bank or other holidays.

Annual leave entitlement will be increased by 37 hours (5 days) in the case of officers who have not less than 5 years' continuous service and by a further 22.2 hours (3 days) in the case of officers who have not less than 10 years' continuous service.

Figures in brackets represent the number of days based upon a standard day of 7.4 hrs.

For individuals who do not work the standard full-time hours, annual leave and extra statutory, bank or public holiday entitlement will be calculated on pro-rata basis to their contracted hours, based on the standard full time hours of 37 per week and a standard day of 7.4 hours (i.e. 7 hrs 24 minutes).

Employees are entitled to a holiday with a normal day's pay for each of the statutory, general and public holidays as they occur. Where the balance of the employee's public / bank and statutory holiday entitlement has been exhausted, additional leave taken for public / bank and statutory holidays will be deducted from the employee's annual leave entitlement.

All employees required to work on extra statutory, bank or public holidays will be remunerated in accordance with Part 3, paragraph 2 of the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service.

The leave year commences on 1 April. If an employee starts part way through the annual leave year, the employee will receive annual leave entitlement on a pro rata basis, calculated on the number of days remaining in the current leave year from the first day of employment.

Sick leave

This scheme is intended to supplement Statutory Sick Pay and Incapacity Benefit so as to maintain normal pay during defined periods of absence on account of sickness, disease, accident or assault. Absence in respect of normal sickness is entirely separate from absence through industrial disease, accident or assault arising out of or in the course of employment with a local authority. Periods of absence in respect of one shall not be set off against the other for the purpose of calculating entitlements under the scheme. Employees are entitled to receive sick pay for the following periods:

During first year of service	one month's full pay and (after completing four months service) two months half pay
During second year of service	two months' full pay, and two months' half pay
During third year of service	four months' full pay, and four months' half pay
During fourth and fifth years of service	five months' full pay, and five months' half pay
After five years' service	six months' full pay, and six months' half pay

Superannuation

The person appointed will automatically become a member of the Local Government Pension Scheme (Northern Ireland) LGPS (NI) in line with scheme regulations. They may opt out of the scheme. However, the council is required to comply with automatic enrolment provisions and will automatically enrol the person appointed at certain times. The LGPS (NI) is administered by Northern Ireland Local Government Officers' Superannuation Committee (NILGOSC) (www.nilgosc.org.uk).

Canvassing

Canvassing in any form, oral or written, direct or indirect, will disqualify an applicant for appointment. Candidates can, however, contact the relevant department for further information about the post. The person from the relevant department who provides further information should not be a member of the selection panel.

Notice

The minimum period of notice to be given by an employee shall normally be the ordinary period from one payment of salary or wages to the next.

Belfast City Council may terminate an employee's employment with the council by giving the following period of notice:

It is usual to give one week's notice to terminate this 'temporary project' post arrangement. Your statutory notice periods which relate to your substantive post with the council remain unchanged.

Probationary period

The person appointed may be required to complete a six month probationary period, if this is a requirement of the relevant department, and during this time one week's notice will be given by the council to terminate employment.


