Main purpose of job

To be responsible to the Safer City Coordinator and to work as part of the Community Safety Team to help reduce antisocial behaviour in local neighbourhoods.

To assist in the development and implementation of a council based antisocial behaviour strategy for Belfast as part of the wider Safer Belfast Plan.

To support the coordination of the council's response to resolving antisocial behaviour at a neighbourhood level and assist in the coordination of this approach at a city-wide level.

To respond to enquiries from the public, stakeholders and elected representatives about specific incidents of antisocial behaviour.

To support a multi-agency response to identified incidents or patterns of antisocial behaviour as required.

To support the use of relevant legislation for enforcement purposes as required.

To develop and, or work with structures set up to engage communities alongside statutory organisations in improving community safety in local areas.

Summary of responsibilities and personal duties

1. To assist with the development, coordination and review of the council's response, alongside other partner organisations, to resolving identified incidents/patterns of antisocial behaviour at a local level and to work as part of a team to coordinate this at a city-wide level.
2. To support the implementation and use of the council's policy and procedures on tackling antisocial behaviour and to update these as required in conjunction with the Safer City Coordinator(s) and Safer City Assistant Manager.
3. To liaise with other organisations and internal departments to assist in the resolution of antisocial behaviour and to support integrated service delivery and ensure effective use of resources.
4. To identify and secure additional resources to support service delivery and to coordinate associated procurement processes.
5. To work closely with the police analyst, and other relevant partners, to assess patterns of antisocial behaviour and best practice solutions.
6. To support communities to develop capacity and to support engagement mechanisms with local communities and organisations to assist in the delivery of neighbourhood based responses and services as required.
7. To ensure the effective reporting and recording of antisocial behaviour within council and in conjunction with other partners.
8. To coordinate the Belfast Antisocial Behaviour Forums which provide a multi-agency response to identified individuals.
9. To ensure the necessary standards of service delivery through the motivation and supervision of assigned staff.
10. To respond to enquiries in relation to antisocial behaviour and to act as a spokesperson to the media and as required within the post-holder's sphere of responsibility.
11. To act as a point of contact for information and advice on matters of antisocial behaviour and potential responses.
12. To assist the coordination of enforcement in relation to antisocial behaviour within council and in conjunction with other agencies; including applications and consultations relating to Anti-Social Behaviour Orders and to act as a professional witness when required.
13. To contribute to the development, implementation and review of the council's Local Area Working action plans.
14. To manage financial arrangements for relevant projects; this includes monitoring and auditing expenditure and the timely submission of accounts to funding bodies, ensuring legal and quality standards are adhered to.
15. To prepare reports which monitor progress against performance measures and deliver briefings as required.

16. To participate as a member of Belfast Community Safety Team supporting positive communication and collaborative working.
 17. To support the delivery of the council's and the City and Neighbourhood Service Department's priorities and objectives.
 18. To ensure the input of required data onto the relevant council data system, for example, FLARE/Civica.
 19. To motivate and manage any staff, that may be assigned, to the postholder to ensure effective service delivery and to be responsible for reviewing and implementing a proper staff training and development programme.
 20. To participate in all induction and in-service training provided by Belfast City Council and in the induction and support of all newly appointed staff and other human resource management policies and procedures, as appropriate, including, absence management, disciplinary and grievance procedure.
 21. To participate as directed in the council's recruitment and selection interview programme.
 22. To act in accordance with the council and departmental policies and procedures including customer care, equal opportunities, health and safety, safeguarding and any pertinent legislation.
 23. To undertake the duties in such a way as to enhance and protect the reputation and public profile of Belfast City Council.
 24. To undertake such other relevant duties as may from time to time be required.

This job description has been written at a time of significant organisational change and it will be subject to review and amendment as the demands of the role and the organisation evolve. Therefore, the post-holder will be required to be flexible, adaptable and aware that they may be asked to perform tasks, duties and responsibilities which are not specifically detailed in the job description but which are commensurate with the role.

Essential criteria

Qualifications and experience

Work planning skills: the ability to plan their own work and manage initiatives or projects.

Equality of opportunity: a clear understanding of equality principles and the ability to apply them when delivering services.

Technical knowledge: a knowledge of community safety and social policy issues.

Job applicant privacy notice

Belfast City Council is the Data Controller under the UK General Data Protection Regulation (UK GDPR) for the personal data it processes relating to job applicants. Processing data from job applicants allows the council to manage the recruitment process, assess and confirm an applicant's suitability for employment and decide to whom to offer a job. It may also need to process data from job applicants to respond to and defend against legal claims.

If you apply for this job, you will be consensually providing your personal data to the council whose lawful basis for processing it is for the performance of a task carried out in the public interest or in the exercise of official authority.

The council will collect a range of information about you, including:

Appointment

The appointment will be made by the selection panel, but will be subject to ratification by the director of the relevant department.

There is currently one permanent, full time post.

There may be a reserve list of applicants drawn up for this post which would last for a maximum of 12 months. Should a similar post become vacant within this time, it may be offered to those on the reserve list, in order of merit, without further interview. For generic-type posts, this may include posts in another department. **These posts may be either full-time, part-time or job-share on a permanent, temporary or fixed-term basis.**

If you are offered and you accept a temporary position e.g. a temporary part-time position for 3 months, and another temporary part-time position arises from the same recruitment campaign e.g. for 1 year, regardless of whether or not you are still working in your temporary part-time position, you will not be offered any further temporary part-time position.

However, in certain circumstances, when all relevant applicants on the reserve list for temporary vacancies, full-time or part-time, have been offered opportunities for which they expressed a preference on their application form, and if the timing of the reserve list is still valid and there are still temporary vacancies to fill before the reserve list expires, the council reserves the right to 'revisit' the reserve list in strict order of merit. Remuneration

The salary will be determined by the council in line with that determined by the National Joint Council for Local Government Services, currently Salary Scale SO2, SCP 26 to 28, £30,984 - £32,798 per annum (in normal circumstances, the starting salary is the minimum point), paid monthly by direct payment by the Bankers Automated Clearing System (BACS) to a bank or building society account of your choice.

Location

The person appointed will be based initially in the Cecil Ward Building, 4-10 Linenhall Street, Belfast but will be required to work in and/or visit other locations.

Pre-employment checks

Prior to taking up duty the person recommended for appointment must:

- (a) Enter into an agreement which sets out the main terms and conditions of employment.
- (b) Provide evidence of the right to work and reside in the UK via an original full UK birth certificate and original proof of national insurance number (for example, via national insurance card, P45 or payslip etc). No temporary national insurance numbers can be accepted. Individuals who do not have a UK birth certificate will be asked to bring their passport and other documentation as required.

- (e) Provide two satisfactory work references. If suitably satisfactory references are not received, they will not be offered the appointment.
- (f) Pass satisfactorily a medical assessment by the council’s Occupational Health Service provider.
- (g) Complete the relevant Northern Ireland Local Government Officers’ Superannuation Committee (NILGOSC) membership or opt out forms.
- (h) Complete a disclosure of family relationships form.
- (i) Complete a disclosure of criminal convictions form, under the Rehabilitation of Offenders (NI) Order 1978. All applicants who are recommended for appointment to a post within Belfast City Council must provide details in respect of any criminal convictions which are not regarded as ‘spent’ convictions. Any disclosed convictions will be taken into account only when the conviction is considered relevant to the post and will be seen in the context of the job, the nature of the offence and the responsibility for the care of existing client/customer and employees.

Council policies

The person appointed will be required to comply with all current and future council policies, procedures, guidelines, agreed working practices and any relevant collective agreements incorporated into the contract of employment.

Conditions

The general conditions of service as prescribed from time to time by the National Joint Council for Local Government Services and by the council for its officers shall apply to the appointment and the Single Status Implementation Agreement dated 2007 as renegotiated from time to time is hereby incorporated into the contract of employment

A copy of the council's Disciplinary Procedure and Grievance Procedure will be issued to all new employees at the council's Induction Course.

Service and hours of duty

The hours of duty are 37 per week, working five days per week, Monday to Friday. Flexible working hours are in operation between 7.30am and 6.30pm, with set core times that the person appointed must be in work. However, the person appointed will be required to start and finish work at specific times that suit the operational needs of the service and they will, when advised, be required to work outside of these hours for operational reasons including on extra statutory, bank and/or public holidays.

In accordance with the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service variations to the established working week or patterns of work will be reasonable and subject to adequate notice.

Annual leave

Annual leave and extra statutory, bank or public holiday entitlement is calculated in hours/minutes.

A person appointed on the standard full time hours of 37 per week will be entitled to 170.2 hours (23 days) annual leave, plus 88.8 hours (12 days) bank or other holidays.

Annual leave entitlement will be increased by 37 hours (5 days) in the case of officers who have not less than 5 years' continuous service and by a further 22.2 hours (3 days) in the case of officers who have not less than 10 years' continuous service.

Figures in brackets represent the number of days based upon a standard day of 7.4 hrs.

For individuals who do not work the standard full-time hours, annual leave and extra statutory, bank or public holiday entitlement will be calculated on pro-rata basis to their contracted hours, based on the standard full time hours of 37 per week and a standard day of 7.4 hours (i.e. 7 hrs 24 minutes).

Employees are entitled to a holiday with a normal day's pay for each of the statutory, general and public holidays as they occur. Where the balance of the employee's public / bank and statutory holiday entitlement has been exhausted, additional leave taken for public / bank and statutory holidays will be deducted from the employee's annual leave entitlement.

All employees required to work on extra statutory, bank or public holidays will be remunerated in accordance with Part 3, paragraph 2 of the National Joint Council for Local Government Services National Agreement on Pay and Conditions of Service.

The leave year commences on 1 April. If an employee starts part way through the annual leave year, the employee will receive annual leave entitlement on a pro rata basis, calculated on the number of days remaining in the current leave year from the first day of employment.

Sick leave

This scheme is intended to supplement Statutory Sick Pay and Incapacity Benefit so as to maintain normal pay during defined periods of absence on account of sickness, disease, accident or assault. Absence in respect of normal sickness is entirely separate from absence through industrial disease, accident or assault arising out of or in the course of employment with a local authority. Periods of absence in respect of one shall not be set off against the other for the purpose of calculating entitlements under the scheme. Employees are entitled to receive sick pay for the following periods:

During first year of service	one month's full pay and (after completing four months service) two months half pay
During second year of service	two months' full pay, and two months' half pay
During third year of service	four months' full pay, and four months' half pay
During fourth and fifth years of service	five months' full pay, and five months' half pay
After five years' service	six months' full pay, and six months' half pay

Superannuation

The person appointed will automatically become a member of the Local Government Pension Scheme (Northern Ireland) LGPS (NI) in line with scheme regulations. They may opt out of the scheme. However, the council is required to comply with automatic enrolment provisions and will automatically enrol the person appointed at certain times. The LGPS (NI) is administered by Northern Ireland Local Government Officers' Superannuation Committee (NILGOSC) (www.nilgosc.org.uk).

Car user

This job will require the post-holder to carry out council duties in all areas and locations across the city and beyond. To do this, the post-holder must have a full, current driving license and have their own transport available for official Council business. For this, the post-holder will be reimbursed at the appropriate mileage rate.

Canvassing

Canvassing in any form, oral or written, direct or indirect, will disqualify an applicant for appointment. Candidates can, however, contact the relevant department for further information about the post. The person from the relevant department who provides further information should not be a member of the selection panel.

Notice

The minimum period of notice to be given by an employee shall normally be the ordinary period from one payment of salary or wages to the next.
